

## Insurance Coverage for Integrated Genetics Prenatal Testing

Your physician has decided to order prenatal genetic testing from Integrated Genetics, a member of the LabCorp Specialty Testing Group. While prenatal testing is frequently covered by insurance, you should contact your health insurance plan to obtain specific details about your individual plan benefit and coverage for this laboratory testing, as well as your out of pocket financial responsibility (such as your responsibility for co-pays and deductibles or any non-covered portion).

### Contacting Your Health Insurance Plan

You can contact your health insurance plan by calling the member services' number located on the back of your insurance card. When calling your health Insurance plan, you will likely want to ask questions concerning your level of coverage, such as the commonly asked questions provided below.

1. Are the test(s) listed below a covered benefit under my policy?
2. Are there any medical criteria that have to be met in order for the tests to be covered?
3. Are there any special requirements that have to be met prior to drawing the specimen for the testing requested; e.g. does my policy require preauthorization of services?
4. What is my out of pocket financial responsibility for the test(s), including any unmet deductibles or co-pays?
5. When researching your specific benefits and coverage, your health Insurance plan may need to know the name/type of test(s) being ordered, and the CPT code(s) that will be used to bill for the service (see the table below)

Your health insurance plan will also need information that can only be provided by your physician or his/her office related to the medical necessity for the testing being requested, such as the diagnosis code(s) assigned by your physician on the day of your visit and the reason that your physician is ordering the tests. This information must be provided by your physician or a member of his/her office staff.
